Performance Commentary

The 5 Oceans Fund was down 0.31% for the month of February. The fund did not price on 31 January due to Auckland Anniversary, but we estimate a return of +0.5% for that day, captured as part of the down 0.31%.

In the global equity strategies, Acadian was down 3.5% and Schroders was down 5.5% (in AUD). These are unhedged returns, the hedges in place contributed 0.6%. Our local strategies had mixed results, with the unconstrained Ranger down 0.7% and the more NZX focused Trans-Tasman up 1.3% (both of these returns are from 28 January and include the positive last day of the month).

The bond funds were also mixed, with T Rowe Price up 0.7% (in AUD) and Daintree down 0.5%. Additionally, the direct mortgage loans contributed positively. New Zealand Emissions Units (carbon credits) were up 5.9% for the month and the Kohinor Core tail risk strategy was down 0.1% (in USD).

Fund Strategy

The 5 Oceans Fund is designed to have a diversified asset and geographic exposure. The exposure to growth assets can be varied between 30% and 70% of the fund depending on the underlying managers' assessment of market risk. This is quite different from traditional diversified funds which often target a set growth allocation and invest accordingly.

The fund achieves this by carefully selecting managers that have flexible investment mandates and/or employ risk mitigation strategies. This gives the fund a dynamic and flexible exposure to growth assets and greater focus on capital protection in the event of market crashes.

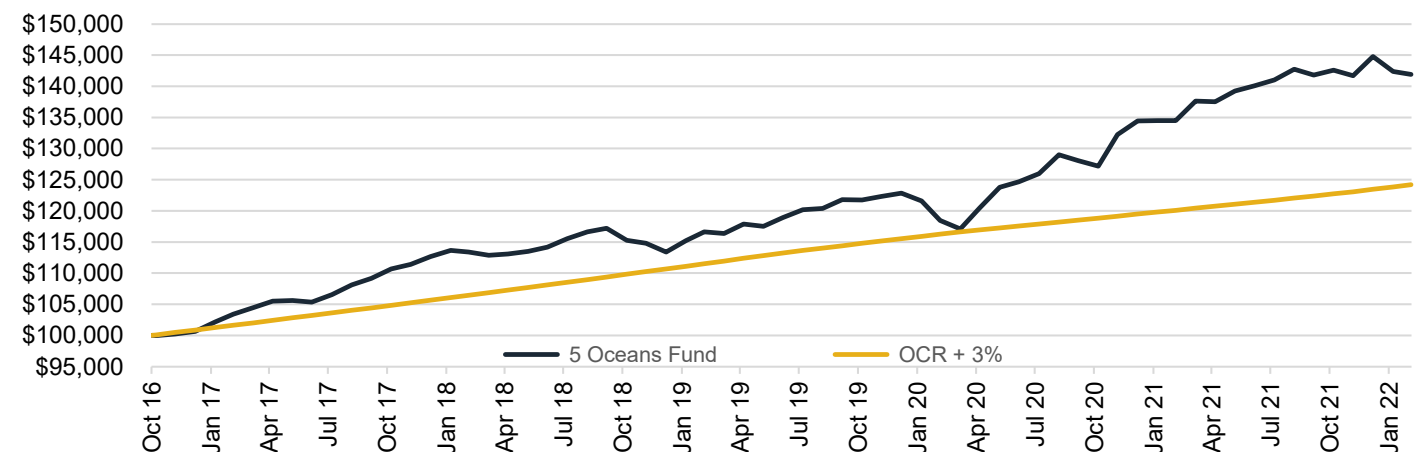

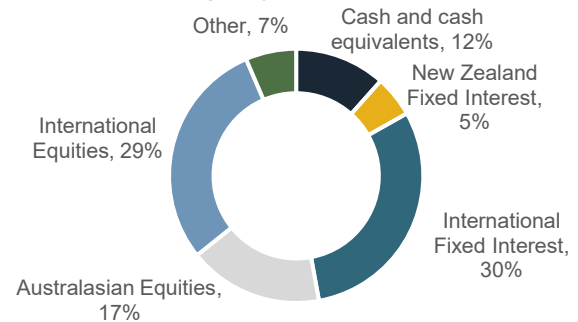
