Performance Commentary

The 5 Oceans Fund was down 0.40% in November as markets continued to gyrate.

The growth orientated strategies had mixed results. The local focused Ranger Fund was down a modest 0.3%. During the month we diversified the local exposure by moving a small amount of the Ranger exposure to our new Trans-Tasman Fund, which was up 1.0% for the period invested. The global equity strategies (Acadian and Schroders) were down 3.3%, although the majority of this was driven by currency and mostly offset by the currency hedging contracts that we have in place.

Bond managers similarly had mixed results, with AMP up 0.1% and T. Rowe Price down 0.2% (in AUD). The Kohinoor tail risk strategy gave up some of its strong October gains in the more sideways November markets (down around 4.5%).

Fund Strategy

The 5 Oceans Fund is designed to have a diversified asset and geographic exposure. The exposure to growth assets can be varied between 30% and 70% of the Fund depending on the underlying managers' assessment of market risk. This is quite different from traditional diversified funds which often target a set growth allocation and invest accordingly.

The Fund achieves this by carefully selecting managers that have flexible investment mandates and/or employ risk mitigation strategies. This gives the Fund a dynamic and flexible exposure to growth assets and greater focus on capital protection in the event of market crashes.

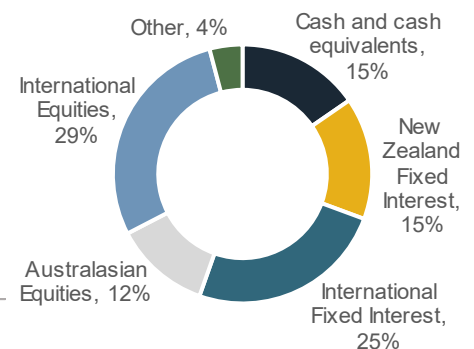

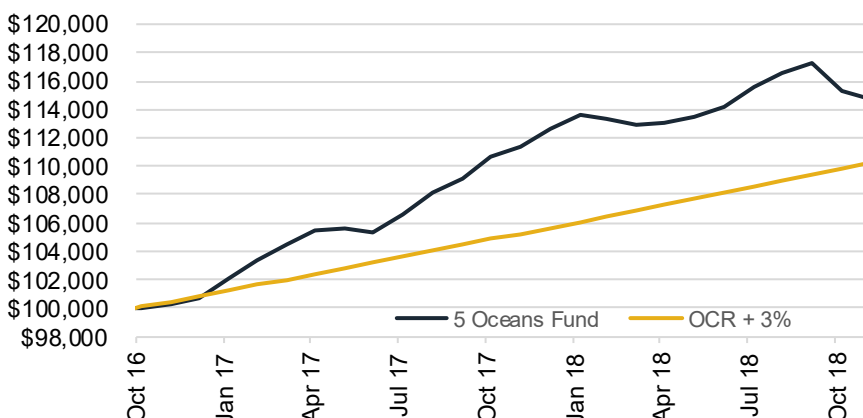
