Performance Commentary

The Ranger Fund was down 0.76% over the last month of the year.

Retail Food Group was the largest positive contributor over the month, with the stock up over 20% as they announced they had resolved the ACCC proceedings that had been outstanding for some period of time. Other contributors were Move logistics (+ 12%) and Boom Logistics (+7%).

Corporate Travel Management (-11%), MoneyMe (-30%) and Macmahon Holdings (-6%) were the main detractors for the month. MoneyMe announced a funding update and reconfirmed their outlook for the year. The update on strategic options to reduce debt, due by June 2023, is key news the market is waiting on.

We have exited our investment in OFX after reaching our price target (up over 100% from our initial purchase price) and added a new investment into Synlait Milk.

Fund Strategy

The investment strategy of the fund is to exploit market inefficiencies resulting from a bias to short term performance by financial market investors, through investing in a range of Australasian assets. Castle Point has broad discretion on the type and proportion of Australasian assets the fund invests into. Given the broad investment mandate of the fund there is no target asset allocation or investment mix. There are some restrictions and investment limits on certain assets. Refer to the fund's current statement of investment policy and objectives.

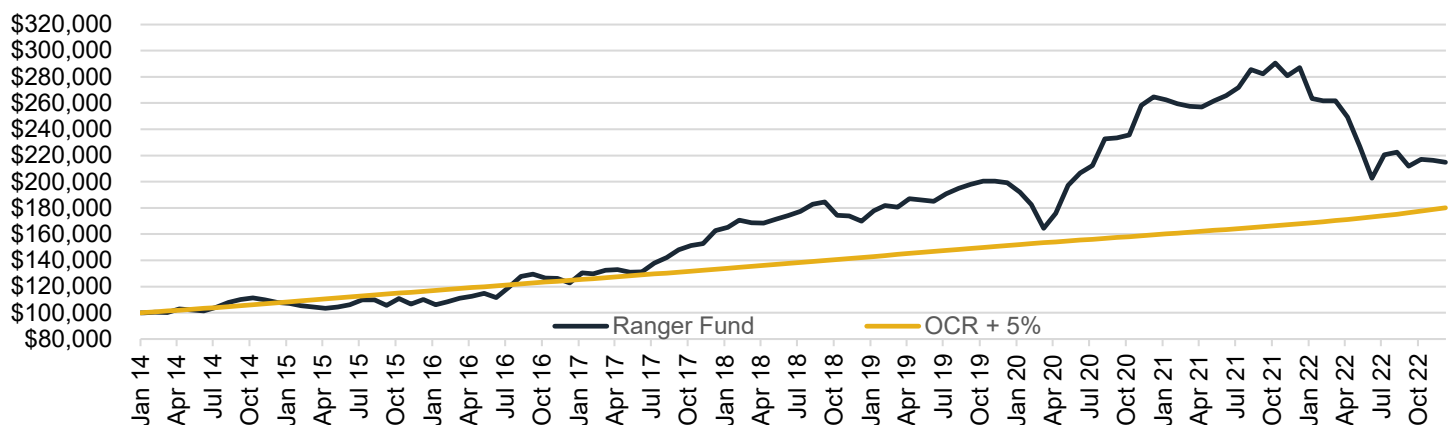

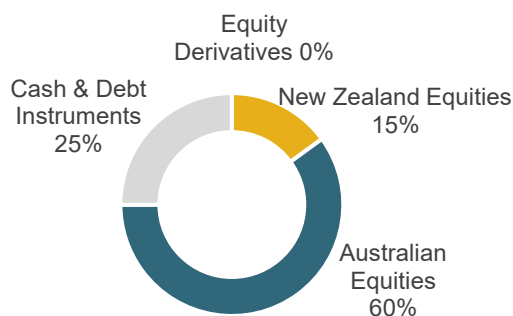

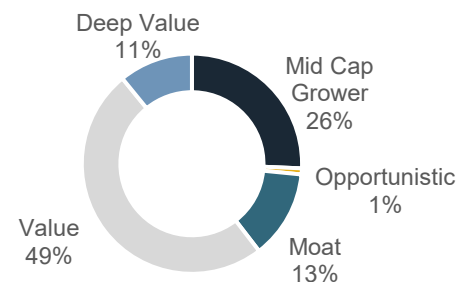

Holdings By Country



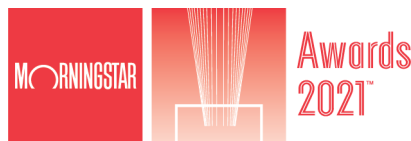
Equity Holdings by Category
