Performance Commentary

The Ranger Fund was up 0.08% over March.

It was a relatively quiet month for company news. Macmahon (+13%), Corporate Travel Management (+9%) and IVE Group (+10%) were the main contributors to performance. Corporate Travel announced ACCC clearance to acquire Helloworld during the month, which has now been completed. The management team at Corporate Travel have a proven ability to make sensible bolt-on acquisitions that are in line with their business strategy and enhance their position in the travel management market.

Redbubble (-15%), The Reject Shop (-10%) and AFT Pharmaceuticals (-10%) were the main detractors.

Fund Strategy

The investment strategy of the fund is to exploit market inefficiencies resulting from a bias to short term performance by financial market investors, through investing in a range of Australasian assets. Castle Point has broad discretion on the type and proportion of Australasian assets the fund invests into. Given the broad investment mandate of the fund there is no target asset allocation or investment mix. There are some restrictions and investment limits on certain assets. Refer to the fund's current statement of investment policy and objectives.

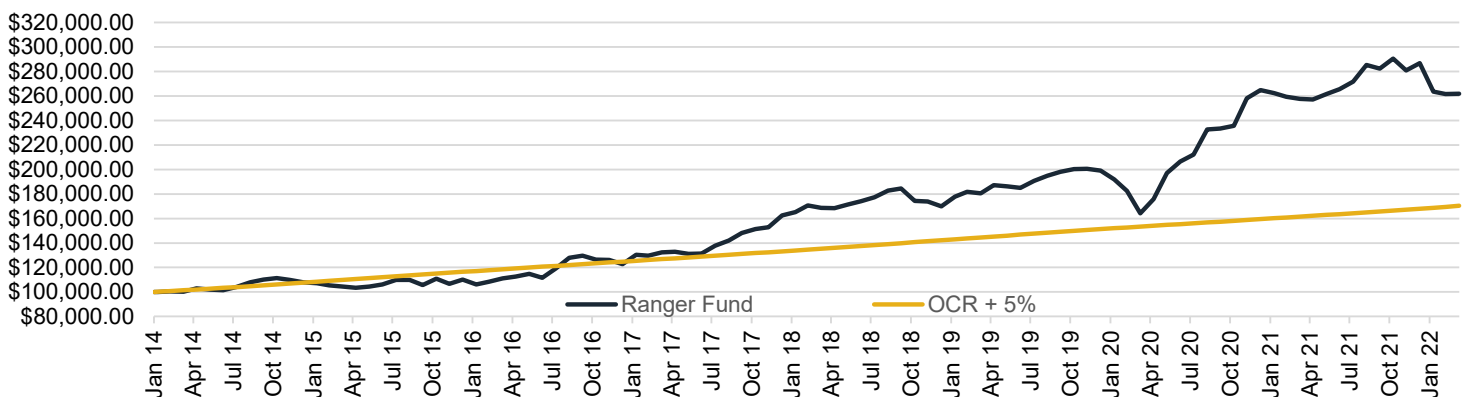

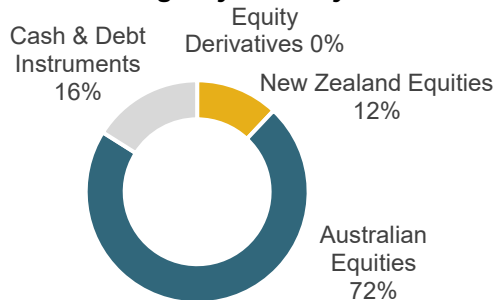

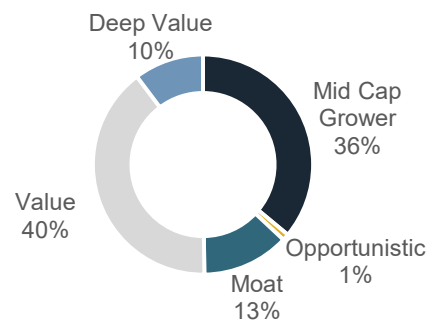

Holdings By Country



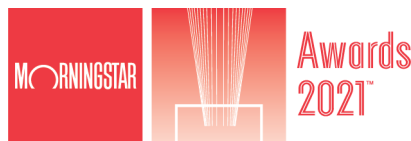
Equity Holdings by Category
