Performance Commentary

The Trans-Tasman Fund was up 3.88% in July, whilst the S&P/NZX50 benchmark was up 3.40%.

Redbubble provided a positive trading update that appeared to allay investor fears about its growth trajectory. Previous trading updates showed lower growth but we noted at the time that short-term numbers are not good indicators of long-term growth. Redbubble's share price was up 55% for the month but it is still below previous highs.

Most overweight positions contributed positively and there were no material negative contributors to performance for the month.

Portfolio Strategy

The Castle Point Trans-Tasman Fund invests in New Zealand and Australian Listed Companies and is benchmarked to the S&P/NZX 50 Index. The objective of the Portfolio is to outperform the benchmark over rolling three year periods. With its high active share the Portfolio targets a tracking error of between 3-6% and will typically have less than 5% in cash at any time.

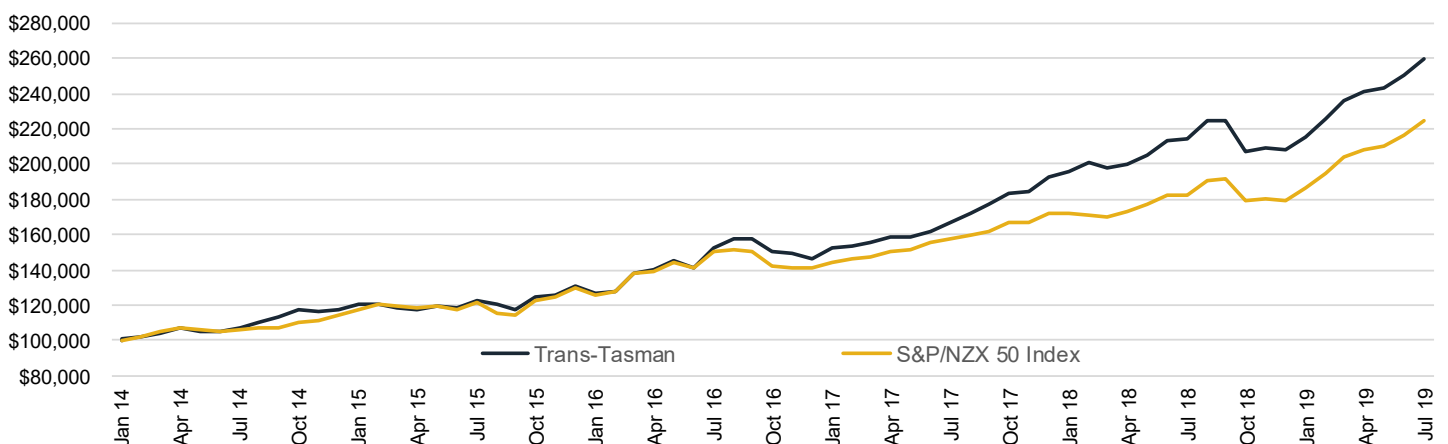

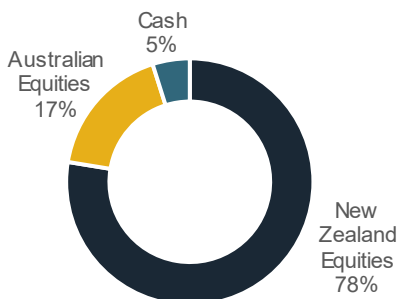

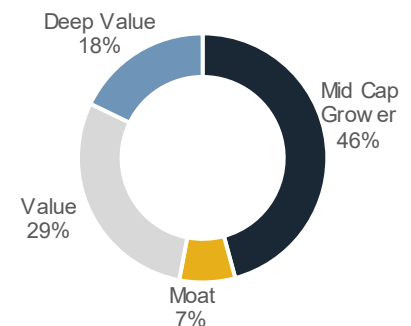
